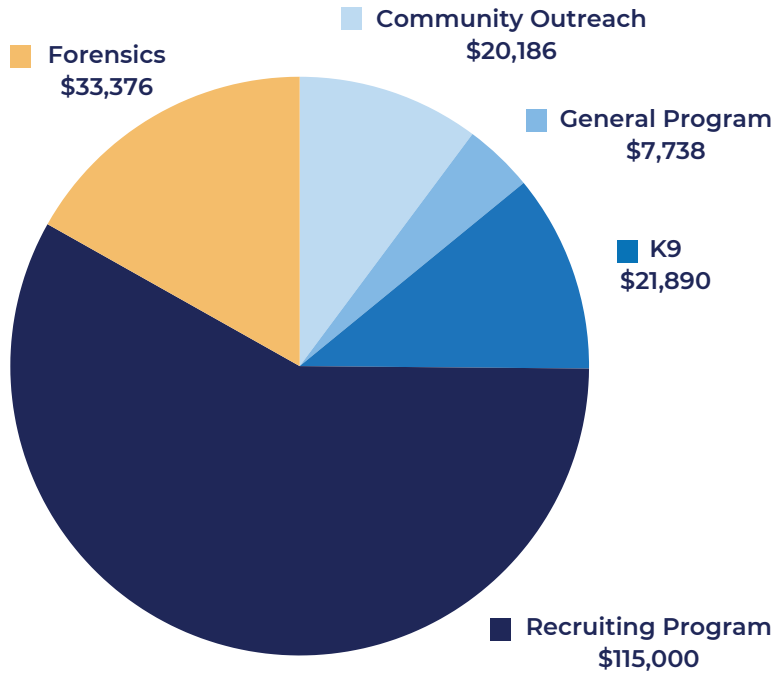

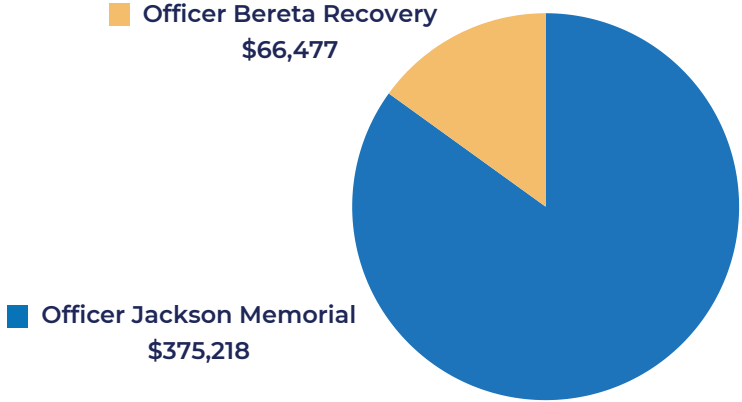


## 2023 GRANTS MADE
